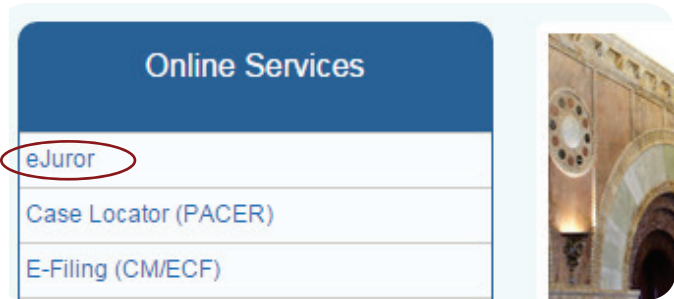

You will not be reimbursed for taxi fare.** Federal employees, except Postal Service and FAA employees, are not entitled to attendance fees. Jury payment and reimbursements are made by check and will be mailed to your address following your jury service. **Remember, if you appear for jury service without checking eJuror or calling the Jury Information Line (800-755-5879), YOU WILL NOT BE PAID.**

What happens if I don't report?

JURORS WHO FAIL TO APPEAR AND WHO ARE NOT EXCUSED OR DEFERRED BY THE COURT MAY BE HELD IN CONTEMPT OF COURT. CONTEMPT PENALTIES MAY INCLUDE A \$1000 FINE, THREE DAYS IMPRISONMENT, COMMUNITY SERVICE, OR ANY COMBINATION THEREOF AS PROVIDED BY TITLE 28, SECTION 1866(G), UNITED STATES CODE.
